Thank you for sending us the revised version of your paper. We recognise its potential importance and relevance to general medical readers, but we think there are a few minor points that need clarifying, as detailed in the report from our statistician.

In addition, I noticed that, following a reviewer's suggestion, you switched the term 'uncertainty intervals' to 'confidence intervals'. You argue the use of uncertainty intervals in this context but switch to confidence intervals to satisfy the reviewer comment. We have been pondering the issue and would prefer that you go back to 'uncertainty intervals' because you produce the intervals from the percentiles of the distribution drawn. The interpretation is the same.

Comments from the statistician

This is an improvement on the original version and all my comments have been addressed. While the heat maps are visually good to look at, the addition of the numerical results for each of the countries is a welcome addition for global readers in Supplementary Table 3. The results are however presented as estimate, UCI, LCI. It would seem more natural to present the LCI followed by UCI.

I do feel as though the article would still benefit from editorial oversight from a copy editor. There are a number of grammatical errors. From a stats view, P value should be p-value. I would also not include '=' for results - I would marry the results in line with the text. Also please make it clear what the units are when talking about all results, e.g. add that it a percentage if that is what it is.
